The Medical Biller works closely with healthcare providers, insurance representatives, and patients to resolve billing discrepancies and maintain compliance with all federal and state regulations.

Key Responsibilities:

- Prepare and submit medical claims to insurance companies (electronic and paper).
- Review and verify patient information, insurance coverage, and coding accuracy.
- Follow up on unpaid or denied claims to ensure prompt resolution and reimbursement.
- Post payments, adjustments, and denials to patient accounts accurately.
